Shadowing

Deirdra has been shadowing key activities over the summer including an introductory meeting in June to review the budget to actuals, closing of the books in July and the audit in August. Rod has not been available to participate in shadowing.

 I will continue to involve Deirdra in activities leading up to the AGM including finalizing the budget for 2019-202 and preparing the AGM presentation so that she is ready for the role of treasurer following the AGM.

Note: We are at a higher risk than normal of swimmers choosing to quit after team selection due to the number of Junior swimmers and the fact that some swimmers will not be interested in swimming on the B team. As a result, I recommend that the board prepare for revenues to be lower than what was outlined in the September draft budget by \$15 – 30K as each junior swimmer that quits will result in \$7,300 less revenue in swimmer fees.

Policy Discussion & Updates

Hope Case

For the past two and half years, the Club with a family regarding their lack of payment (5K). At the end of July, the court provided judgement in favour of the Club.

Brent Hooey provided his services to the Club pro-bono as a lawyer. I would like to make a motion that the Club approves to buy Brent a small gift to say thank you and to express the organization's gratitude for his help with this very difficult situation.

AQB Handbook

Over the summer the AQB Handbook was updated for

distribution during registration. A few policies were removed (Dispute and

Resolution Policy, Appeals Policy) to shorten the length of the booklet as well

as all content was checked to ensure that the referenced material actually

existed. The information left in the handbook is critical to protect the club from any future misunderstandings with members and to ensure that we are

following Club Excellence requirements. The information in this handbook helped the Club win the grievance with the one family two years ago and win our lawsuit this past summer. The information in it is important.

I would like to thank all of the members who took the time to review the handbook and provide feedback. Together we made this booklet the best reference piece of information for the members.

AQB Policies

The other task completed over the summer was the reformatting of our policies into a consistent format to be uploaded to the website. For the most part, I was able to take the copy verbatim and reorganize it into the correct layout.

One policy that was a bit more challenging was the Volunteer Policy. I needed to make a number of changes to it to fit the new format. I tried not to change its intent but I did change the copy so the new version is going to require board approval.

Please review the AQB Handbook Volunteer copy and then the proposed Volunteer Policy prior to the next meeting where we will take a vote on the revised policy. Below is the copy of the volunteer policy that is in the AQB Handbook and attached to this email is the new proposed version.

AQB Handbook Volunteer Policy Copy

As a not-for-profit organization, the Aquabelles rely on our members volunteering to fulfill important roles, both operational and strategic. Some of these roles include fulfilling shifts at our club-hosted meets, counting lengths at the swim-a-thon, helping out with fundraising efforts, volunteering on a meet committee, sitting on the Board of Directors, etc.

Aquabelles families are required to submit a \$500 post-dated cheque (June 1, 2020) at time of registraton that will only be cashed if a family fails to fulfill their volunteer requirements.

As the volunteer requirements change from year-to-year based upon the number of meets that the club will be hosting the <u>exact requirements will be communicated at the AGM in October.</u>

Hosting competitive meets allows the athletes an opportunity to compete, sleep and eat at home, saves families money by reducing travel costs and helps raise funds for the club to reduce overall fees. Competitive meets are volunteer run and therefore every family, whether it is a national or provincial meet is required to volunteer regardless of whether or not your own child is swimming in the meet.

Expectations for meet volunteering is as follows:

- Family <u>minimum</u> meet volunteering commitment PER MEET =
 (1 shift x the number of days of competition hosted by the AQB)+ the number of children who swims with the AQB club.
- Judging shifts do count towards the club volunteering commitment, but shadow judging does not.

- If expectations per meet are not met or discussed in advance with the volunteer manager and vice president, your volunteer deposit cheque will be cashed.

The Calgary Aquabelles are mainly a volunteer run club. Everything that needs to happen that makes this club a success is volunteer driven. That means every family must step up to help with club operations. Besides volunteering at competition meets hosted by the Aquabelles, every family must also volunteer for an operational role such as the recruitment committee, fundraising committee, swim-a-thon organizers and lane counters, Board of Directors, cooler repair, meet organizing committee, judging meets, chaperoning etc. The club's expectation is that each family will contribute an additional 25 hours of volunteer time to ensuring the smooth operations of the club each season. If expectations are not met or discussed in advance with the volunteer manager and vice president, your volunteer deposit cheque will be cashed.

The purpose of this policy is to clearly outline the volunteer expectations and try to equalize the volunteer efforts of all members while creating engagement with the club.
